

## EVENT PARTICIPANT FORM INSTRUCTIONS

**All participants attending AJJF Events must hold a current registration with the AJJF.** If a participant is not currently registered with the AJJF, they must pay a temporary registration fee to attend the event.

The fee for a one-time event registration is \$5. Event Hosts are asked to include this fee as part of the event cost for participants who are non-AJJF registrants. (That is, non-registrants should be charged \$5 more than registrants to attend your event.)

Non-registrants do not need to complete the standard AJJF registration application. Instead, they will

- Print the participant name neatly
- In the checkbox, indicate if the participant is 18 year of age or younger
- Sign the form on the same line
- Write Event-Only in the AJJF# column

**All event participants and instructors must sign the Event Participant Form.** This provides documentation that everyone on the mat during an AJJF event is a current AJJF registrant.

**The Event Host will send the Event Participant Form, along with payment equal to \$5 per non-registrant listed, to the AJJF Central Office.**
